



## COST Action CA18102 The European Aquatic Animal Tracking Network (ETN)

### Call for Applications – Virtual Mobility Grants

This is a second Call for applications for Virtual Mobility Grants of the COST Action CA18102 and will be open **from 1<sup>st</sup> May 2022**.

#### Purpose of Virtual Mobility Grants (VMG)

The role of digital tools to support the activities of the ETN in the spasms of the COVID 19 pandemic is indispensable. The COST organization designed new virtual networking tools in order to build capacity and spread the uptake of virtual collaboration across different research communities. While the benefits of face-to-face meetings can never be replaced by digital platforms, the virtual tools and supporting grants will provide our COST action the needed support and incentive to make the extra mile.

Virtual Mobility (VM) Grants allow researchers and innovators to continue and expand cooperation in a virtual setting. These activities may include surveys, courses, workshops, preparation of protocols, harmonisation and standardisation of methods and procedures, virtual mentoring and a range of other activities that do not necessarily require personal presence. These grants are like “virtual STSMs” and also offer the opportunity to perform at least part of a potentially cancelled STSM virtually.

#### Eligibility Criteria

Applicant(s) must be ETN CA 18102 participants with a primary affiliation to an institution located in a COST Full or Cooperating Member country or MC Observers from a COST Near Neighbour Country.

The activities for VM Grants have to be finished until the **15<sup>th</sup> September 2022**.

#### Topics

Activities planned within VMGs should contribute to one of the following CA 18102 ETN specific goals:

- Data import in ETN of big datasets with large value for ETN
- Inclusion of PIT data into database
- Data-analysis/literature review for ETN papers
- Video editing/ populating the you-tube channel
- Improving/populating the website

#### How to apply

The application process in details is as follows:

1. All applicants must carefully read the funding rules detailed in Section 10.2 of the *COST Vademecum*. This document is available at: <https://www.cost.eu/uploads/2021/06/Vademecum-V9-28-April-20212-1.pdf>.
2. All applicants must register for an e-COST profile at <https://e-services.cost.eu/> - adding their bank account details and CV to their profile.



The list of documents to be submitted in PDF format for the evaluation are:

1. The VMG **application form**.
2. A **full CV** (including a list of academic publications – if applicable).

### Application deadline

Due to the time constraints the applications will be evaluated on a first-come-first-served basis until the funds are finished or until the 15<sup>th</sup> of August 2022, whichever occurs first.

### Evaluation

The evaluation is based on the contribution of the virtual mobility application to the overall objectives of the Action. The applications will be assessed by the STSM/ITC-CG Committee, which will evaluate the application against the perceived contribution that the proposed VMG will make to the specific topics described in this call. Applicants should expect to receive a response **within 2 weeks** after submission.

Unless specifically requested by the applicant, all received materials or parts of them, including personal information and the final report (or parts of it) of the VMG may be published on the Action website. Applicants can ask for (and justify) an embargo on information linked to their application if they wish.

### Approval of the application and grant amount.

Based on the outcome of the evaluation and the proposal of the STSM/ITC-CG Committee, the Core Group of ETN (COST Action CA18102) will approve the application and the grant amount. The maximum amount per VM Grant is **EUR 1.500**. A maximum of 6 Virtual Mobility Grants can be awarded per GP.

### Reporting

The VM Grants have to be concluded until **the 15<sup>th</sup> September 2022** and the report submitted within 30 calendar days from the completion of the VMG.
